



Technological Park: Through the Parque Technologico de Uberaba the city offers a hub of scientific and technological production in Brazil gathering academic research, government support and companies interests in a 1,6 millions square meters area.



Industrial areas: More than 17 millions of square meters in industrial districts available in Uberaba to settle your industrial plant with adapted access to water, energy and soon, gas.



Uberaba has one of the best incentives law of the country to attract investments. Our incentive law received the entrepreneur award from SEBRAE (Serviço Brasileiro de Apoio às Micro e Pequenas Empresas), offering taxes suspensions and donation of industrial areas through the valuation of 12 criterions like investment, job creation or technological development.



A LOGISTIC HUB LINKING THE WEALTHY SOUTH TO THE DEVELOPING NORTH OF BRAZIL



Dry Port - Uberaba has an intermodal terminal directly connected by road and rail to Brazilian seaports and operates as a center for the transshipment of sea cargo to its inland neighbors.

Uberaba's inner port also offers facilities for storage and consolidation of goods, maintenance for road or rail cargo carriers and customs clearance services.

EPZ - Economic Processing Zone offers suspension of federal taxes in a 2,7 millions square meters zone of free trade.





VLI - The largets rail logistics hub of the world.

VLI is structured in five large corridors (Center-North, Center-Southeast, Center-East, Minas-Rio and Minas-Bahia). Therefore, they ensure higher capillarity and internalization, reaching regions with high expansion potential in all the segments: agricultural and mineral commodities, industrialized and steel products. In Uberaba, VLI is beginning with a huge intermodal hub customizing logistic solutions to ensure maximum agility and efficiency to handle cargo types like grains and sugar.
